#### **Overview**

Data Protection training has never been more important. Research shows that over half UK organisations do not understand and comply with current legislations. The new European General Data Protection Regulation (GDPR) is coming into force in May 2018, and will be included in the new UK Data Protection Act 2017.

Those handling personal data must be adequately trained. The information Commissioner's Office (ICO) recommends 2 hours data protection training per person per year. Over 50% of UK breaches last year were attributed to "inadvertent human error".

Companies cannot hope to meet the requirements of the new legislation unless everyone in the organisation who processes personal data (or PII) understands the key requirements of GDPR.

#### How it works

#### **GDPR** in Practice

This module teaches the key definitions and 6 principles of the GDPR, the key features of PECR, and GDPR's subject rights and data transfer issues. The module is in 2 parts.

- 1. Part one focuses on giving information in a creative, engaging way using interactive gaming technology to involve learners and encourage them to find out more.
- 2. Part two involves learners in applying the knowledge they have gained.

#### **Recognising Personally Identifiable Information**

This module teaches learners how to recognise personal data (or personally identifiable information) and sensitive personal data / special category data, to put GDPR into context

#### **Information Security Awareness**

This module teaches the importance and key elements of data security awareness, including PCI requirements.



## **Learning Outcomes**

Quizzes and questions are used at the end of each stage to identify the level of understanding of the training provided. Students must pass with 88% to get their CPD points for GDPR and ISA.
